



## TUBI STYLE TERMS & CONDITIONS

### PRODUCT FEATURES – EXCLUSIVELY SPORTS USE

*Tubi style* products have not been approved (and cannot be approved) for road use and are exclusively intended for circuit use. Use of these products on public roads is prohibited by road traffic regulations and may lead to fines, which will be payable by the driver of the vehicle.

As our products are not intended for road use, but only for achieving the best performance from the vehicle in track testing, they do not conform to regulation standards concerning noise emissions for motor vehicles. Their use could furthermore determine exhaust emission levels that do not comply with parameters for standard approval.

### FACTORY WARRANTY OF THE VEHICLE MANUFACTURER

Our products **MUST** be fitted by **specialist technicians with specific know-how in the field, i.e. sports teams providing assistance to circuit vehicles. Avoid DIY tampering as this may expose the driver to personal risks.**

Once the circuit test has been completed, our products **MUST** be removed and replaced with the originals.

Use of our products on the road may result in the vehicle's factory warranty being invalidated due to variations to the vehicle's standard approval parameters described above.

### OUR PRODUCT WARRANTY

1. Subject to the conditions set out below the Manufacturer warrants that the Products shall correspond with their specifications at the time of delivery and shall be free from defects in material and workmanship for a period of 24 (twenty-four) months from the date of sale to the enduser, (evidence to be given: commercial invoice showing the serial number and code of product) or for a period of max 36 month from the invoice date issued from the Manufacturer to the Dealer.
2. The above warranty is given by the Manufacturer subject to the following conditions:
  - a) the Manufacturer shall be under no liability in respect of any defect arising from willful damage, negligence, abnormal working conditions such as the use for car racing, failure to follow the Manufacturer's instructions (whether oral or in writing), misuse or alteration or repair of the Products without the Manufacturer's approval;
  - b) Any Product delivered by the Manufacturer to the Dealers under this Agreement shall be sold with the technical warranties referred to in this agreement.

THE FOREGOING WARRANTIES ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE".

3. To allow the punctual fulfilment of the undertakings of the Warranty herein described the Customer shall take all the necessary care and steps to preserve the information on the traceability of the Products so that the Manufacturer can identify the Product from its origin and activate the guarantee. In particular, during after sale guarantee period the replacement or reparation of defective Products shall operate only if a copy of the invoice showing the serial number of the product is sent to the Manufacturer. Manufacturer shall be entitled to ask, at its discretion, to the Customer to send any claimed Product to Manufacturer's premises to verify the reasons of the claimed defect.

4. The Customer shall immediately inform the Manufacturer of any claim, action or proceeding by third parties concerning the Products.
5. Any claim by the Customer which is based on any defect in the quality or condition of the Products or on their failure to correspond with specifications shall be notified to the Manufacturer within two working days from the date of delivery or (where the defect or failure was not apparent on reasonable inspection) within 8 working days after discovery of the defect or failure.
6. Where any valid claim in respect of any of the Goods which is based on any defect in the quality or condition of the Goods or failure to meet specifications is notified to the Manufacturer in accordance with these Conditions, the Manufacturer shall be entitled to replace the Goods (or the part in question) free of charge or, at the Manufacturer's sole discretion, refund to the Customer the price of the Goods (or a proportionate part of the price) but the Manufacturer shall have no further liability to the Customer.

#### **CERTIFICATION AND DISPOSAL**

Our company has been recognised **UNI EN ISO/TS 16949** quality certification, which guarantees the highest product and service levels for our clients. Tubi Style operations are also environmentally friendly and comply with the management directives listed in **ISO14001**.

Our products can be recycled, with the exception of any residual soundproofing material (silica fibre < 500 gr), and catalysers for versions which have them (to be disposed in accordance with current laws). If unused, the product must ALWAYS be entrusted to a disposal specialist.

#### **TECHNICAL INFORMATION FOR INSTALLATION**

Unless otherwise specified, our components are manufactured for *plug and play* use on the vehicles for which they are intended. Please refer to the workshop manual for the vehicle model in question for correct installation of our components. Further information is available on [tubistyle.it](http://tubistyle.it).

#### **THE RISKS OF INCORRECT INSTALLATION**

Incorrect installation may cause vibrations, noise, interference, damage to vehicle components, overheating potentially leading to fire.

#### **REGULATIONS OF REFERENCE**

In international regulations, our products can be defined 'nonstandard *tunings* exclusively for sports purposes'. Domestic regulations concerning these products must be checked prior to use.
